HUMAN SCIENCES TRANSFER AGREEMENT BETWEEN NORTH CAROLINA CENTRAL UNIVERSITY AND SOUTHWESTERN COMMUNITY COLLEGE

North Carolina Central University (NCCU) welcomes qualified students transferring from Southwestern Community College to investigate the opportunities for completion of the Bachelor of Science in Human Sciences (BS) degree (Child Development & Family Relations) at NCCU. Credit for college transfer courses completed at SCC will transfer to NCCU as detailed below.

TRANSFER ABILITY FOR COURSE WORK COMPLETED AT SCC Students who have completed the college transfer (AA or AS degree) or the 44 hours Core Curriculum approved under the Comprehensive Articulation Agreement (CAA):

Upon admission, NCCU's general education, or CFAS (Critical Foundations in Arts and Sciences) requirements are waived, except for one physical activity course (1-2 credits) and six semester hours of one modern foreign language. Students completing a physical activity course with a grade of C or better at SCC will have fulfilled NCCU's physical education requirement. Students' completing levels I and II of the same modern foreign language at SCC with grades of C or better will have fulfilled NCCU's foreign language requirement.

Students who complete a technical degree program (e.g., A.A.S.), or who do not complete a degree or the Core Curriculum approved under the Comprehensive Articulation Agreement (CAA) must, upon enrolling at NCCU, satisfy all of NCCU's CFAS and Human Sciences requirements. The courses offered at SCC listed on the following page will transfer in fulfillment of NCCU's CFAS and Human Sciences requirements, as indicated, if the grade earned is C or better.

Students who do not complete a college transfer degree and who are under 24 years of age must meet UNC System Minimum Admissions Requirements (MARS) from high school, or an approved alternative, to be admitted to NCCU.

The maximum number of hours-accepted from two-year colleges is 64 semester hours. Students completing college transfer degrees (AA or AS degrees) will transfer with 60 semester hours of Credits. Students who earn other two-year degrees and students who do not earn degrees with have their classes evaluated on a course by course basis. Students who meet all admission requirements will be admitted to NCCU on a space available basis.

NCCU reserves the right to modify this agreement and the transferability of courses completed at SCC and will notify SCC of any modification of college transfer and Human Sciences courses. SCC agrees to notify NCCU of any modification in courses listed as part of this agreement.
