The Board of Trustees of Southwestern Community College (SCC) met for their bi-monthly meeting on March 22, 2022 in the Charles Siler Slagle Board Room of the Conrad G. Burrell Building on the Jackson campus.

CALL TO ORDER

Chairman Lambert Wilson called the meeting to order at 5:10 p.m. and read the Conflict of Interest Statement. A quorum was present for the meeting.

PREVIOUS MEETING'S MINUTES

Mr. Wilson asked for a motion to approve the minutes of the Board of Trustees Meetings of November 16, 2021, January 25, 2022, and February 25, 2022. Mr. Hyatt made a motion to approve the minutes as presented, and Mr. Shields seconded the motion, which passed unanimously.

PRESIDENT'S REPORT

Dr. Tomas announced that the Open House for the new Health Sciences Center will be held on Friday, April 8 at 10 AM, and encouraged the Trustees to attend.

Dr. Tomas announced the Legislative Meet and Greet hosted at SCC for State Senator Kevin Corbin and State Representatives Karl Gillespie and Mike Clampitt on March 23, 2022. This event will include discussions with members of the Board of Trustees, faculty, staff, and student representatives, and Executive Cabinet.

Dr. Tomas announced that he will be attending the joint NCACCP meeting/NCACCT Law and Legislative Seminar March 30 through April 1, 2022 in Raleigh. Also attending the NCACCT Law and Legislative Seminar will be Chairman Wilson, Mr. Cloer, and Mr. Hyde.

Dr. Tomas reported that SCC's Office Administration program was named Best in the Nation by BestAccreditedColleges.org.

Dr. Tomas reported that the SCC Foundation has received \$1,085,850 in donations and gifts from July 2021 to March 2022.

Dr. Tomas presented the agenda for the upcoming Cultural Fusion event at the Jackson campus on March 30, 2022.

Dr. Tomas introduced Savannah DeHart as the new director of Institutional Research and Planning at SCC.

CURRICULUM AND STUDENT SERVICES

Curriculum and Student Services Committee Chair Jean Ellen Forrister asked Dr. Thom Brooks, Executive Vice President for Instruction and Student Services, to report to the Board.

Dr. Brooks introduced Kayla Cooper, recipient of the Dallas Herring Award for SCC, and Isaac Quillen, the SCC recipient of the Academic Excellence Award. They spoke briefly about their experiences as students at SCC.

Dr. Brooks reported on the Fall 2021 Workforce and Continuing Education enrollment, as well as the Spring 2022 Curriculum enrollment, both trending up over the same periods last year.
