Students applying to Health Science programs will follow the chart below for meeting application, documentation and additional testing deadlines and requirements. **Students must meet with program coordinators to determine if** additional criteria for evaluating applicants are administered by each the program.

C. Admission Appeals for Limited Enrollment Programs. Applicants who are denied admission to limited enrollment health sciences programs may appeal the admission decision as follows:

1. Within 10 business days of denial of admission, applicants ~~may~~ **must** submit a written letter of appeal to the Dean of Health Sciences outlining the basis for the appeal and attaching any relevant documents supporting that basis.
2. The Dean of Health Sciences will provide a written decision regarding the appeal to the applicant within 10 business days of receipt of the appeal letter.
3. If the applicant disagrees with the decision of the Dean of Health Sciences, he/she may submit a written letter of appeal (together with any relevant documents) to the Executive Vice President of Instruction and Student Services. This appeal must occur within 5 business days following the decision by the Dean of Health Sciences.
4. The Executive Vice President of Instruction and Student Services will decide the appeal based upon the consistent application of program admission

5. The Executive Vice President will communicate a written decision to the applicant within 10 business days of receipt of the letter of appeal. The decision of the Executive Vice President is final.

NOTE: A “business day” as referenced in this policy is defined as a weekday when classes are in session.
