**A. Limited Enrollment Programs.** The Health Sciences programs identified in the chart below are designated as limited enrollment programs. Enrollment in these programs is restricted and subject to capacity limitations imposed by, but not limited to, clinical site availability, instructor-to-student ratios mandated by accrediting and/or approving agencies, and the availability of instructional facilities, equipment, and other required educational resources.

**B. Admission to Limited Enrollment Programs.** Students applying to Health Sciences programs shall adhere to the application procedures, required documentation, testing requirements, and associated deadlines as outlined in the chart below. Applicants are required to meet with a designated success coach/academic advisor to determine whether the program requires additional evaluative criteria as part of the admissions process.

**C. Admission Appeals for Limited Enrollment Programs.** Applicants denied admission to limited enrollment Health Sciences programs may appeal the admission decision in accordance with the procedures outlined below:

1. Within ten (10) business days of receipt of the admission denial, the applicant must submit a written letter of appeal to the Dean of Health Sciences. The appeal must clearly state the basis for the appeal and include any supporting documentation relevant to the claim.
2. The Dean of Health Sciences will review the appeal and issue a written decision to the applicant within ten (10) business days of receipt of the appeal.
3. An applicant who disagrees with the decision of the Dean of Health Sciences may submit a subsequent written appeal, including any supporting documentation, to the Executive Vice President of Instruction and Student Services. This appeal must be submitted within five (5) business days following the decision by the Dean of Health Sciences.

4. The Executive Vice President of Instruction and Student Services will review the appeal to determine whether program admission criteria and scoring were applied consistently in the evaluation of the applicant's original application. A written decision to the applicant within ten (10) business days of receipt of the appeal. The decision of the Executive Vice President of Instruction and Student Services shall be final.

**NOTE:** A "business day" as referenced in this policy is defined as a weekday when classes are in session.
